


## Pillars of independent living

- An adequate Income
- Appropriate & accessible information
- Full access to environment
- Appropriate and accessible health & Social Care provision
- A Fully accessible transport system
- Availability of peer counselling
- Availability of accessible and adaptable housing
- Adequate provision of technical aids and equipment



### An adequate income



#### **Example of where this hasn't been fulfilled:**

- Support staff using individuals to make budget cuts
- Institutional barriers stop disabled people from working
- Changes in benefits assessments has meant that people cannot use their support to find work
- Charging costs for social care

#### **Example of where this has been fulfilled:**

 Family putting pressure on the government to ensure that their child/relative can live a happy and fulfilled life with good income




### Appropriate & Accessible information

#### **Example of where this hasn't been fulfilled:**

- Not being given information about self directed support
- Information not being widely available about ASD
- Parents aren't being made aware of SDS (In Scotland)

#### **Example of where this has been fulfilled:**

Organisations are working on information being more accessible






#### Full access to environment

### **Example of where this hasn't been fulfilled:**

- Having pavements covered in smashed bottles
- In the community, lack of accessibility in a built environment i.e. pavement kerbs
- We feel like we live in a society that values buildings over people
- Lack of accessible environment means that we can't participate with our peers or engage in our community

#### **Example of where this has been fulfilled:**

Not allowing individuals who use public services access to inaccessible buildings

## Appropriate and accessible health and social care provisions

#### **Example of where this hasn't been fulfilled:**

- Hospitals not having the resources/facilities to cater for those with access needs
- Individuals having to travel further and remove from their community in order to access services
- When accessing health services, i.e. hospitals, you are not allowed to bring with you your existing support-this can be removed from you whilst using the health service
- Individuals feeling punished for accessing health services
- Introductions of pre-payment cards
- Services/local authorities are fearful of giving people creative solutions to provide support because of fear & backlash

#### **Example of where this has been fulfilled:**

Moving towards joining health & social care (budgets)



A fully accessible transport system

#### Example of where this hasn't been fulfilled:

- Public transport staff aren't appreciative of mobility requirements
- Can't be spontaneous when travelling if you have a certain access requirements, because you need to notify operators
- Lack of accessible spaces on transport services. This impacts on social networks and leads to costly and segregated approaches i.e. travelling to school

#### **Example of where this has been fulfilled:**

- Scotrail's ticket collectors are trained in BSL
- They have also been trained in accessibility for getting on and off trains



## Availability of peer counselling

#### **Example of where this hasn't been fulfilled:**

- Current peer support systems feel unnatural
- Peer support is not currently considered a priority

#### **Example of where this has been fulfilled:**

- Local authorities matching families together, so that families starting on the journey can be linked with families who have already experienced the services.
- Current examples such as: the LADDER group (Doncaster) Demonstrates the importance of peer support





## Availability of accessible and adaptable housing



#### **Example of where this hasn't been fulfilled:**

- "Creating" accessible community environments/homes-another form of segregation and institutionalisation
- Lack of information on accessible features for the home
- Local authorities are moving back to the idea of care and cluster
- Current forms of providing homes is leading to bullying and abuse because of a segregated culture

#### **Example of where this has been fulfilled:**

• Ensuring that young people see the opportunity to own as accessible home is a realistic aim



# Adequate provision of technical aids and equipment



#### **Example of where this hasn't been fulfilled:**

- Unique technical aids-process often takes a long time which impacts negatively on the individual
- Assisted technology is not a substitute for existing support
- Technology is not there to fix the impairment. It's there to enhance participation

#### **Example of where this has been fulfilled:**

- Technology developing and advancing
- Universities are researching into better advanced technological aids for individuals
